SECTION 2: Hazard identification

General hazard statement

SECTION 4: First-aid measures

4.1 Description of necessary first-aid measures

Eye contact

Flush eyes with copious amounts of water for at least 15 minutes. If irritation develops or persists, seek medical attention.

Skin contact

Remove contaminated clothing and wash affected area with soap and water thoroughly. If irritation develops, seek medical attention.

Inhalation

Evacuate to fresh air immediately. If unconscious, place in recovery position and provide artificial respiration if breathing ceases. Seek medical attention.

Ingestion

DO NOT induce vomiting. Wash mouth out with copious amounts of water and seek medical attention.

First-aid facilities

Eye wash station, safety shower and First Aid kit.

4.2 Most important symptoms and effects, both acute and delayed

The most important symptoms and effects are described in Section 2 (hazard statements) and Section 11 (toxicological information).

4.3 Indication of immediate medical attention and special treatment needed

SECTION 5: Fire-fighting measures

5.1 Suitable extinguishing media

Use an extinguishing medium suitable for the surrounding fire and other material involved. Water spray, dry chemical powder, carbon dioxide or foam.

5.2 Specific hazards arising from the chemical

Combustion may produce toxic and irritating gases.

5.3 Special protective actions for fire-fighters

Fire fighters should wear self-contained breathing apparatus (SCBA) operated in positive-pressure mode and full protective clothing. Fight the fire from a safe location.

SECTION 6: Accidental release measures

6.1 Personal precautions, protective equipment and emergency procedures

Ensure adequate ventilation. Avoid contact with skin and eyes. Wear suitable protective equipment (see Section 8). Evacuate non-essential personnel from the area.

6.2 Environmental precautions

Prevent the spill from entering drains, sewers and waterways. In the event of a major spill, contain the material and notify the relevant authorities.

6.3 Methods and materials for containment and cleaning up

Contain the spill and prevent entry into drains, sewers and waterways. Absorb with inert absorbent material (e.g. sand, vermiculite or earth) and transfer to a suitable, labelled container for disposal. Rinse the affected area with water. Dispose of in accordance with Section 13.

SECTION 7: Handling and storage

7.1 Precautions for safe handling

Avoid contact with eyes, skin and clothing. Use only with adequate ventilation. Wash hands thoroughly after handling. Do not eat, drink or smoke when using this product.

7.2 Conditions for safe storage, including any incompatibilities

Store in a cool, dry, well-ventilated area. Keep containers tightly closed and upright when not in use. Store away from incompatible materials (see Section 10). Inspect containers regularly for damage or leaks.

Eye/face protection

Skin protection

Clean impervious clothing should be worn. Clothing for protection against chemicals should comply with AS 3765 Clothing for Protection Against Hazardous Chemicals.

Hand protection

Use occupational protective gloves complying with AS 2161 (Selection, Use and Maintenance).

Respiratory protection

If engineering controls are not effective in controlling airborne exposure then an approved respirator with a replaceable vapour/mist filter should be used. SECTION 10: Stability and reactivity

10.1 Reactivity

Reactive dialdehyde. In aqueous solution glyoxal exists mainly as the hydrated monomer and oligomers; concentrated solutions can polymerise on standing. Reacts readily with amines, ammonia and proteins (a known cross-linking agent) and with strong oxidising agents.

10.2 Chemical stability

Stable in dilute aqueous solution under recommended storage conditions. Concentrated solutions may polymerise or form precipitates on prolonged storage.

10.3 Possibility of hazardous reactions

Can react exothermically with strong oxidising agents. No hazardous polymerisation is expected under normal handling of this dilute (2.5%) solution.

10.4 Conditions to avoid

Freezing, extremes of temperature, prolonged storage, direct sunlight and contamination.

10.5 Incompatible materials

Strong oxidising agents, strong bases, amines and ammonia.

10.6 Hazardous decomposition products

Thermal decomposition or combustion may produce carbon oxides (carbon monoxide and carbon dioxide).

Acute toxicity

Persistence and degradability

Glyoxal, present at 100 mg/L, achieved 65% of its theoretical BOD in 2 weeks using an activated sludge inoculum at 30 mg/L and the Japanese MITI test. Glyoxal was classified as readily biodegradable in a closed bottle OECD 301D test

Bioaccumulative potential

An estimated BCF of 3 was calculated for glyoxal, using an estimated log Kow of -1.66 and a regression-derived equation. According to a classification scheme, this BCF suggests the potential for bioconcentration in aquatic organisms is low

Mobility in soil

Highly mobile in soil (Koc = 2.1 L/kg; miscible in water). Partitions almost entirely to the aqueous compartment
